BUSINESS

Stanly County Health Department Public Health Educator, Debbie Bennett presented council with a community health assessment report. A county health survey was done Jan. 14, 2021 to Feb. 14, 2021.

Lake Patrol Officer, Darnell Almond said 3 years ago, the sheriff's office (SCSO) restructured lake patrol with a focus on safety and visibility. SCSO and Badin Police have a mutual aid agreement and work together well.
