### **BUSINESS**

At the request of Stanly County Schools Superintendent Dr. Jeff James, Nancy Hatley, Director of Stanly County Virtual Education (SCoVE) for Stanly County Schools, provided a presentation to inform Council about SCoVE which is primarily for K-12 homeschool. Hatley hopes council will share SCoVE with homeschool parents.

Council considered adopting a resolution opposing the unfunded mandate proposed in Senate Bill 179 and House Bill 278 (SB179/HB278) Parity for First Responders. SB179 and HB278 Parity for First Responders seeks to add a new separation allowance retirement benefit for firefighters and rescue workers much like the separation allowance for qualifying law enforcement officers. There is no indication the state will offer funding at any level for the benefit but would require towns and cities to foot the bill. Council was presented with messages from NC City and County Management Association (NCCCMA) President and Wilson City Manager Grant Goings and NCCCMA Retirement Committee Chair Ken Noland. Milano requested more information.
