BUSINESS

Council reviewed draft ordinance regulating food trucks, peddlers, and itinerant merchants. Mayor Harwood would like more time to review. Council will revisit in September meeting.

Council reviewed draft forms and guidelines for tree and bench donations. Milano would like to see procedure for Albemarle's Liberty Gardens. Council will revisit in September meeting.

Almond received a request for a family reunion to be held in West Badin Park in September. Recent event was approved for 25 people, however many more attended. Parking was a major issue and there was extreme concern over emergency vehicles inability to access homes as a result. Council discussed Alcoa parking lot, McDonald Church parking lot, possibly First Baptist Church parking lot, and field area inside West Badin Park as possible alternatives. Officer Dissler said BPD has temporary no parking signs that may be useful.

Peoples asked how a street name change would get started. Almond recommended Council may speak with National Register of Historic Places to begin impact determination. He will work to set up a meeting. Carter said Powell Bill maps would have to be updated if street names were changed. Harwood said address changes would have to be made for every affected resident for shipping purposes and again for emergency services. Peoples asked Almond to research it.
