NC DOT Scenic Byway Coordinator Connie Morgan presented a proposal to council to reroute Valley Drive Scenic Byway in Badin. Morgan would like to update the byway to include more of Badin. Her proposal begin the route on Falls Rd., follows Maple St. to Kirk Place to Boyden St. and merges with Valley Dr. Currently the route begins on Nantahala St., moves along Henderson St. to Valley Dr. The route update would add historic downtown and museum features to the posted route through Badin. Milano asked about widening and repairing Valley Dr. Morgan will seek information on repair criteria for Valley Dr. Council would like school to still be a part of the byway route.
