PUBLIC COMMENTS

Albemarle resident Joey Hicks, whose mother lives in Badin, asked about work on Willow Street and reported talking with construction workers. He requested an update from Town Hall.

Pat Leonard complained of vegetation on former golf course. She read in Town of Badin Ordinance 10-3 that weeds are a nuisance and property owners should be coded. She said her backyard is full of animals, she believes her property value is lower because of the growth and she's afraid to let her grandchildren outside.

Nancy Vasser said she believes overgrowth at the former golf course is unsafe for family, pets, or the elementary school. She believes property values have declined and the town should address vegetation in the undeveloped area through the town's nuisance ordinance.

Stanly County Schools Superintendent Dr. Jeff James introduced himself and North Stanly High School Principal, Dr. Randy Mann.

Kevin Thomas of Lynn Thomas Grading addressed resident concerns regarding Willow Street. He assured them Willow Street is not a secondary project. The dirt underground is unsuitable due to high volumes of rain. Rock underground is causing delays. They are doing their best. He is on the job site every 2-3 days and requested residents ask him questions anytime he is there. He estimated a timeline of 6 weeks for project completion.

Almond suggested residents seek information from Town Hall rather than work crews.

Mayor Harwood administered Oath of Office to Gary Lowder who was appointed to fill the unexpired term of former Council member Ryan Hatley. Hatley resigned an at-large council seat in December. Lowder promised to do everything in his ability to make Badin a better place.

Jeff Littlefield, Division Maintenance Engineer from NC Department of Transportation, discussed the condition of and maintenance requirements of NCDOT trees along Falls Road in the Badin Central Business District. Trees are in DOT right of way. Local tree expert says these trees are 100 years old but are aesthetic. Littlefield asked the town's approval for DOT to remove the trees. There are 6 trees considered hazards. He's not sure about stump removal. If town wants to replant other types of trees in the right of way for aesthetic purposes, DOT would have to approve it. Harwood would like to see tree replacement program information.

Sam Smith, Engineer from Chambers Engineering, presented council with detailed images of the planned planter median on Falls Road at Hwy 740 in Badin. DOT approval is needed and normally takes about 3-4 weeks. There are 3 shrubs and an annual planting bed planned.
