BUSINESS

American Legal Publishing via NC League of Municipalities has a codification program. This includes legal review, code copies, binders, printing and editing. Total cost will be around \$9,750 plus \$450 annually if the town chooses to place the code online through ALP. Chief Lambert recommended council approve codification. Nuisance and noise ordinance are in the most need. Codification was being considered for 2018/2019 budget, but may be needed sooner.

Council reviewed Town of Badin Ordinance 12-3, An Ordinance Regulating the Use of Non-Motorized Recreation Vehicles and Skateboards in the Town of Badin. Hatley presented council with a proposed amendment to the ordinance. Need to add "prohibits careless and reckless behavior," and clearly list rules in Section 3. Almond is to bring a clean copy for next meeting.

Hatley would like council to consider mailing out notices to residents that town will be stricter in code enforcement. Almond is to make samples for council to consider.

- 5. Misenheimer will host the Stanly County Council of Governments meeting February 27th.
