### **BUSINESS**

Council discussed implementation of a mini or "spot" social district at Loafers & Legends. Councilman Council considered whether full width of sidewalk needed inclusion in the district. Mayor Lowder preferred under awning outdoor dining area to side patio only.

Council discussed options for deer population control. Wildlife biologist previously said that moving 150 deer will impact population for only approximately 3 years.

Council considered a business development grant application of up to \$1,500 from Badin Coffee owner Jack Benoy. Annual application deadline, April 30<sup>th</sup>. Town has 2 applications.

Council considered request to close alley off Roosevelt St. A related request brought to council in 2008 died on the table. New request required. Avonda Thomas requested closure of a portion of the Roosevelt St. alley. Council needs more information on how to proceed. A dead-end alley was reportedly closed 20 or more years ago off Chestnut St.

RFQ solicited for architect/engineering firms as well as construction firms. One for each was received. Almond will check with grant administrators to determine if town may accept as submitted or if town must re-advertise.
