#### **BUSINESS**

Almond and Chief Lambert recognized Badin Police Officer Michael Taylor for outstanding achievements working toward personal and Badin community enrichment. While a member of the Badin Police Department, Officer Michael Taylor furthered his life preparedness when he earned an Associate's Degree in Criminal Justice as well as an Advanced Law Enforcement Certificate.
