#### **POLICE REPORT:**

Chief Smith gave the June police report.

- There were 2,176 calls for service in June.
- 2 New part-time officers have been sworn in.
- 1 Full-time officer is awaiting paperwork and is radar certified.
- Police Dept. appreciates council and community's support.

## **PUBLIC WORKS:**

Almond reported the following:

- Next limb/brush collection will be August 3, 2021.
- Boom mower is repaired.
- Off-Street parking at Holly place is completed. Check on signage.
- Precision Safe Sidewalks completed FY21 work. FY22 may begin. Council said proceed.
- Dry stack repair work on Spruce St. stone ditch is ongoing.

Mayor Harwood said West Badin Park mowing needs completing, and asked about West Badin Park Pavilion. Almond said Contractor hopes to be completed by end of August.

#### **FINANCIAL REPORT:**

Almond presented financial report period ending June 30, 2021. Tax revenue from property, occupancy, and sales & use tax.

#### **MANAGER'S REPORT:**

Almond reported the following:

- 1. Deloris Chambers will attend CVB 8:30 a.m., July 14<sup>th</sup>, and COG meeting that afternoon.
- 2. Stanly St. ditch is awaiting contractor.
- 3. Attorney is looking over letter to property owners regarding trespassing on town owned properties. Milano asked Almond to follow up with attorney.
- 4. NCDOT will only work curb to curb on Falls. Lowder said council needs to approach NCDOT.
- 5. Council will participate in a local Health Focus Group with the Stanly County Health Dept. 4 p.m., July 14<sup>th</sup> in Badin Conference Center.
- 6. Badin Town Council will host a planning session 5 p.m., July 14th in Badin Conference Center.
- 7. Next Regular Council Meeting, 7 p.m. Tues., August 10<sup>th</sup>, in Badin Conference Center.

### **COUNCIL COMMENTS:**

Almond met with Historic Places representative. Street name changes would not affect registry status. Milano stated that there needs to be a lot of discussion before changing street names. Mayor Harwood would like to invite museum to a meeting to discuss.

Chambers reported the following: Jackson St. has a large pothole; 225 Lincoln St. is in code violation; vacant house on corner of Washington St. is in code violation.

Milano reported the following: Furniture left out on Hickory St.; Young unsupervised kids at Pine St. Park, need speedbumps to slow traffic.

Huntley mentioned the need to look at storm drains on Spruce & Maple Streets.

Lowder mentioned a storm drain issue on Cheoah St. and asked when town hall will open back up.

Chambers asked about status of burned building next to town hall.
