Mayor Lowder presented the Sidewalk Café Ordinance Permit for Loafer's and Legends.

Town Council considered adoption of proposed Town of Badin Street Name Change Ordinance. Ward had concerns about the "No duplicate names in the County" guideline. Lowder said that it was recommended by Stanly County not to use duplicate names.

Town Council considered an ordinance to surrender a portion of a public alley in the General Business District off Roosevelt St. between Sumpter and Jackson streets to private owners. No opposition was received.

Discussion: Lowder said paid invoices from alley closure requestors, will cause plat delivery to the Stanly County Register of Deeds. Requestors were charged for the plat.

Gary Rife, Chairman of the Planning Board proposed a land use plan. He said the plan is a working document that must be adopted by July 1, 2023 ensure compliance with NCGS 160D. The planning board would like more feedback from the community before revisions.

Eudy reported the following:

- Spruce St. wall repair should finish this week.
- Library trees trimmed.
- 2 speed signs have come in.
- Electrical work for Christmas Lighting has been completed.

Lowder asked about Spruce St. ditch. Eudy said catch basin cover and wall repair are needed.

POLICE REPORT:

• Sergeant Hawkins reported 2,011 calls for service in May.

Lowder asked if citizens can get updates on arrests. Hawkins said police can give updates if a case is closed. Some cases close quickly, some remain open for a year or more. Hawkins said they patrol troublesome areas more frequently. Ward asked about a shooting on Marion St. Hawkins said Badin PD is working with Albemarle PD on that case. Sarah Allen said she worries about traffic on Sherman St. and is concerned kids playing in the street could be hit be speeders. Lowder said speed signs will assist the police department with speed data.

FINANCIAL REPORT:

Almond presented financial report ending June 9, 2023. May revenue from property tax, sales & use tax, occupancy tax.
