Opening prayer by Deloris Chambers. Pledge of Allegiance to the Flag recited.

### **PUBLIC COMMENTS**

Dale Ward noted Spruce St. ditch repairs, Pine St. Park playground equipment, and thanked town for Magnolia/Poplar St. work.

Renita Ritchie addressed Non-Residential Standards Ordinance letter, saying clear sidewalks don't draw business. She would prefer allowable item guidelines, so businesses can leave items on sidewalks rather than make requests, and said businesses in Badin are tourism driven.

Alwasi Rida mentioned one pothole in the alley behind Grant St. and one at Wood & Grant streets. He said the community should attract more tourism to Badin.

# **BUSINESS**

Rachel Taylor and Jess Wilkinson of NCGrowth presented "Developing a Recreation & Heritage Tourism Strategy" for Badin. They discussed project goals, research, challenges & opportunities, asset map, lessons from case studies, and recommendations.

Council reviewed tree and bench donation policy. In cost sections, council would like to change "non-refundable deposit of 15%" to "flat fee of \$50 non-refundable administrative fee due with application." In approval section - each instance, change "town makes all final determinations" to "town council makes all final determinations." Fix numerical errors in top section.

Council reviewed parking, Spruce from Maple to Boyden, Maple at Nantahala, and Holly Place.

Motion to restrict parking on right side Spruce St. (facing Boyden) from Maple to Boyden streets except

school days 1:30 - 2:30 p.m.: Lowder

Second: Chambers Vote: Passed/Unanimous

Motion to restrict parking on Maple St. at Nantahala intersection for approximately 40 ft. to allow emergency vehicle access to make the turn: Lowder

Second: Huntley

Vote: Passed/Unanimous

Motion to change parking on Holly Place to 45-degree angles: Lowder Discussion: Council preferred review of Holly Place parking options Lowder rescinded motion.

Council reviewed non-residential standards ordinance letter, and would like to allow exemption for current restaurant tables. Almond will notify restaurants of exemption upon letter delivery.

Motion to deliver non-residential standards letter as is with restaurant table exception: Chambers

Council discussed infrastructure needs. Stanly St. needs repairs, \$1,700 for ditch. Surface repair will have to wait. Spruce St. ditch will begin after contractor meeting.

Chief Smith gave the February police report.
