PUBLIC COMMENTS

Richard Aldridge reported drainage issues in the alley between Falls Road and Nantahala streets. He said the area has flooded 3 times in the last few months. He would like to have town look at it.

Sherrill Mullis reported the same drainage problem. Drain pipe under falls cracked and was sleeved Tony E. Hawley construction. The sleeve stabilized the pipe but reduced its functional diameter, slowing water flow. Mullis contacted NCDOT with no response.

Meredith Stinnett reported the same flooding. She said Meredith's Beauty Salon has flooded, causing issues with patron parking on Falls Road. Water is entering their cars.

Almond noted how the water flow has changed following water project. Carter said an oak tree damaged the pipe. How the pipe is addressed may be affected by its location in NCDOT right of way.

Milano requested town call NCDOT about the pipe and plan to address county commissioners about town roads affected by the water project.

Roger Watson introduced himself as the new publisher at the Stanly News & Press. He said he found temporary lodging in Badin and has enjoyed being in the town.
