Lowder and Almond met with Chris Lambert from Stanly County CVB about the 10 days of Uwharrie. CVB will pay for a banner and develop a Facebook page for 10 Days of Uwharrie, North Carolina's Official Outdoor Festival.

Chambers said swings in West Badin Park are unstable, dirt and dead weeds on Roosevelt St. at median need attention, and 225 Lincoln St. is overgrown.

Milano asked about property cessation letters. Almond reported deliveries already underway.
